Advocacy Spotlight

Jen Cole is an advocate and mother from Everett

As a young child, Jen Cole immigrated to the United States with her mother. Witnessing the unfair treatment and discrimination both she and her mother received, Jen pursued a career in human services before the birth of her first child, Gabriel. Gabriel was born with a rare chromosomal deletion called 7q11.23, also known as Williams-Beuren Syndrome. Jen has always been concerned about social justice issues, and continues that work today, especially as it intersects with disability and race.

"I'm involved in all sorts [of advocacy]! Mostly educational. I currently serve on the Snohomish County DD Advisory Board, the Washington State Coalition for Language Access, the City of Everett Diversity Advisory Board, the WA State Rehabilitation Council for DVR, and the Special Education Advisory Council (SEAC) for OSPI. I also serve as the SEAC rep on the State Interagency Coordinating Council (SICC). I also serve on multiple workgroups for the state."

Times have been very up and down for Jen and her family: "I have experienced unfair treatment and discrimination as it intersects with issues related to my appearance, my gender, and as a full-time working mother raising a child with a disability. Trying to work with individuals and organizations who are not interested in change or centering those furthest from opportunity [hasn't worked]. Forming collaborative relationships and reaching out to others has worked though. I love organizations such as the Arc of Snohomish County who do so much to meet folks where they are and connect them with others."

Like everyone, 2020 has presented a bevy of new and unique challenges for Jen and her family. "COVID has presented all sorts of unexpected challenges and I don't think there is enough space to get to them all! [I've had surprising success] connecting with others that I did not expect to, and my son is doing pretty good right now with remote instruction. It didn't happen overnight, but it is happening!

Jen has a last piece of advice for anyone navigating this world. "Relationships and connections are everything and sometimes, even years later, you will find support that you never expected."

Thank you Jen for your hard advocacy work, and we look forward to seeing your continued success moving forward.

Advocacy in Action

Legislative Notebook Recap

On December 7th, the Arc of Washington State had it's yearly Legislative Notebook meeting for the upcoming legislative session. This annual event covers the myriad of topics presented in the notebook, and often features many calls to action for the upcoming legislative session.

This year saw the notebook meeting, like everything else, done completely remotely for the first time. The morning session featured a breakdown of the theme, "Zooming in on Developmental Disabilities," a rundown of all the issue

papers within the notebook, and many other explanations of the charts, graphs, and data contained within.

This year also featured a fantastic question and answer session with four state senators about many topics of concern for the I/DD community. The senators in attendance were Senator John Braun (R), Senator Emily Randall, Senator Christine Rolfes (D), and Senator Sha-



ron Brown (R). All four senators are known allies of the I/DD community, and have shown they are willing to fight for our rights in the past.

The four senators present spoke very candidly about the upcoming budget issue facing our state and how those shortfalls will affect the I/DD community. There will be budget cuts somewhere, but it is unknown where they will come from at this time. All four senators spoke about how the budget crisis has illuminated many shortcomings and pitfalls that currently exist within our state, and how certain financial savings have already been made because of the pandemic. Potential sources of revenue have appeared, but the requirements to use them to plug up the holes in the budget are less then ideal. This is an issue that will be at the forefront of the upcoming legislative session in its entirety.

The afternoon session began with a massive overview of the data included within the notebook. Charts, graphs, and surveys were presented to show where services for the I/DD community currently stand, where they could be, and where we want them to be. This data will be pivotal in discussions with legislators about improving services moving forward.

Finally the day ended with an exciting new proposal about a potential omnibus bill for I/DD services. This idea is still in the beginning planning phases, but would encompass the entire field of I/DD issues moving forward, instead of putting forth smaller, individual bills to further the causes of the I/DD community. As this proposal is currently in its infancy, there is no specific information at this time, but stay tuned for more in the future.

Advocacy in Action

Legislative Forum Recap

Prior to the November 3rd elections, The Arc of Snohomish County hosted a legislative forum for all seven of our legislative districts. They were hosted by members of our community who lived in those districts, The Arc invited all of the candidates running for the state legislature and invited them to discuss their stances on issues important to the I/DD community.

The turn out for these forums was phenomenal. The vast majority of candidates who were running were able to attend, and several who could not sent in written statements or prerecorded messages. Every candidate expressed great concern regarding how the looming budget crisis will affect the I/DD community, and every candidate offered reassurances that they did not plan on cutting services to the most vulnerable among us.

Priorities

- · Maintain the Current Level of Services
- Maintain the Current DDA (Developmental Disabilities Administration) Eligibility Requirements
- Close RHCs, Expand SOLAs & Other Community Housing Options
- End Subminimum Wage
- · Increase provider Wages
- Community Based Respite and Support Services For Families

Candidates were each given three questions ahead of time to answer during the forum, and afterwards was an open question session for the attendees to ask candidates any and all questions that they wanted. The three questions each candidate was asked were 1), What are your top three legislative priorities and how would they serve people with intellectual and developmental disabilities? 2), With the current economic crisis, how would you protect services that people with intellectual and developmental disabilities and their families need? What is your plan for addressing the budget shortfall and how would it serve individuals with disabilities? And 3), Is there other information you would like constituents with developmental disabilities and their families and friends to know?

Election results

November 3 has come and gone, and with it we have a new batch of State Representatives and Senators. Nearly all of our Snohomish County elected officials attended the Legislative Coffee events presented by The Arc of Snohomish County, and every single one of them has expressed interest in continuing the conversation in Olympia.

While the majority of legislators were re-elected, there are a few new faces for this upcoming biennium. Below are some of the new legislators who will be in Olympia representing Snohomish County when the legislative session begins January 11.

Greg Gilday(R) defeated Angie Homola to win the 10th District Position 1 seat in the state legislature. Representative-elect Gilday is filing the seat vacated by Norma Smith, who held the seat for the last six terms and did not run for reelection. Representative —elect Gilday lives on Camano Island with his wife and two sons.

Emily Wicks(D) was appointed to the 38th District Position 1 in May to fill the seat vacated by Representative June Robinson when she was appointed to fill the 38th District Senate seat vacated by Senator John McCoy. Representative Wicks then went on to defeat Bert Johnson in the general election. Representative Wicks lives in Everett with her partner.

April Berg(D) defeated Mark James to win the 44th District Position 2 seat in the state legislature. Representative-elect Berg is filling the seat vacated by Representative Jared Mead. Representative Mead held the seat for one term and did not run for re-election. Representative-elect Berg lives in Mill Creek with her family.

All of our new house members were able to either attend our legislative forums in person, or submitted responses to the questions we asked. The Arc of Snohomish County looks forward to working with all of our new lawmakers, and our current ones, in this upcoming Legislative session.

Annual Leadership Appreciation



Coming Up!

Advocacy Days

Now that we have received the 2020 legislative notebook, we now have the schedule for the advocacy days for the upcoming legislative session. This session will be very different from years past, with the bulk of the session being done online. This grants a unique opportunity for advocates to get involved, as travel to Olympia is no longer necessary to participate in the legislative process. Remote access will allow people who cannot travel to Olympia to be able to communicate, testify, and do everything else that is normally done in person at the capitol.

2021 marks the first year of a new biennium, and with that a longer session. A long session means there are more advocacy days, and combined with the extra access afforded through a remote session, advocates have



a chance to do more then ever before. Here are the first few advocacy days The Arc of Washington State has upcoming.

January 20—Legislative Briefing/Reception

The annual kick off to the legislative session, this will be the first legislative briefing and reception held remotely. Like past years it will begin with the initial session briefing, followed by the reception in the evening. Lawmakers will attend like in years past, so take advantage of the opportunity to connect and mingle in a social setting.

January 27—Session Overview: Budget

The first themed advocacy day addresses the biggest issue facing the state this upcoming biennium: the budget. The priority for legislators this session is to pass a balanced budget. They will be looking at cutting programs, raising revenues, using the state's Rainy Day Fund, and more. Our voices need to loudly say in unison—No Cuts to DD Services!

February 3—Community Residential

Supported living providers have been on the front lines of this pandemic from day one, taking care of clients why they themselves are exposed to COVID. Join providers, family members, and self-advocates to let legislators know how important it is that these providers are paid a fair living wage.

Federal Bills of Interest

Ongoing COVID-19 Recovery

Currently, congress is working on both avoiding a government shut down, and how to extend COVID-19 supports beyond this year. Currently, the CARES act expires December 31, and with it the protections it offers. Congress is currently working on an extension package to go beyond the new year, but as of now they are currently at an impasse. Current proposals vary from whether or not stimulus checks are included, whether or not businesses will receive immunity from COVID related workplace events, and much more. Contact your federal legislators and let them know that a COVID-19 recovery package needs to be put in place for the new year to continue financial protections for those most vulnerable.
