ADVOCACY SPOTLIGHT

The Kumar family from Bothell are taking their first steps into the advocacy world in order to advocate for their son, Shastha. Shastha has cri du chat syndrome, and lives with his parents, Kumar Gounder and Sumangala Kumar. Shastha's older brother Lakshin is also an important part of his advocacy family.

During The Arc of Snohomish County's Legislative Forum series, Sumangala Kumar and her family took their first advocacy step in hosting the forum for the 1st Legislative District. Here their entire family shared their story and the concerns they have regarding services to the legislators and candidates who attended. Supported by Arc Staff Jessie Moore, they were able to tell their story in an extraordinarily powerful manner, and were phenomenal hosts. The inclusion of their entire family in the process and telling of their story really helped show how much work is needed by everyone



in a family when there are a lack of supports and providers for individuals with IDD.

The Kumars have had several issues with Shastha's care, among those being simply living here, away from family. Not having family around to help has placed the onus of care exclusively on their shoulders, with little chance of natural respite. Sudden changes of schedule and plans abruptly needing to be cancelled have also been a challenge to explain to friends when they occur.

However, several things have been very positive. Shastha is making a lot of progress in his therapy sessions. School has been a positive for him as well, with the support and service he needs being provided there. Most importantly, upon diagnosis, Shastha was given very low expectations for his development – expectations he has easily blown out of the water, to the delight of his family.

QUARTERLY FOCUS LEGISLATIVE ADVOCACY

On the second Monday of January every year, the state of Washington begins its annual legislative session. The Arc of Washington State, among other organizations, promote and encourage advocating as this is the best way to impact positive change in the community.

The 2023 Legislative session is around the corner and The Arc of Washington State is once again running their weekly Advocacy Day series. Every Wednesday during the Legislative session, The Arc of Washington State has a theme for each day to address with your legislators. By having these themed days, all of our legislators are hearing about the same issues at the same time, joining your voices together and combining for a more powerful message.

NEW LEGISLATORS

With the results of the November 5 election, we have several new legislators in Snohomish County. Here, in their own words, is a brief introduction from our new legislators.

10th District, position 1 - Clyde Shavers

Clyde Shavers is a U.S. Naval Academy graduate and U.S. Navy Veteran, non-profit leader and volunteer, and environmental law advocate. As the son of a police officer and U.S. Marine, Clyde grew up in Washington in a family dedicated to public service. His father served as an undercover narcotics detective placing his life on the line for over two decades. His mother worked hard to raise Clyde and his sister by instilling in them the value of independence, compassion, and commitment to life-long public service. 39th District, position 1 - Sam Low

Sam and his wife Mariah were both born and raised right here in Snohomish County. Prior to being on the Snohomish County Council Sam was a successful small business owner for 10 years. His wife Mariah is the General Manager for the Lake Stevens Sewer District. Together they have five children and two dogs, Auggie a Silver Lab and Sarge a Golden Retriever. Sam holds two college degrees, a Bachelor of Arts Degree in Theology; and a Master's Degree in Organizational Leadership from MBU. In 2013 Sam was elected to the Lake Stevens City Council and was selected to be Council President in 2016, where he served as Mayor Pro-Tem. During this time Sam also served on the Snohomish County Board of Health and was selected Chair of the Health District in 2015. Sam was elected to the Snohomish County Council in 2016 and re-elected in 2017 and 2021. Sam is active in community service both personally and through his local Lake Stevens Rotary Club where he served as President in 2016-2017.

NEWS AROUND THE ARC

EVERETT POLICE DEPARTMENT ADVOCACY

The Everett Police Department recently asked The Arc of Snohomish County to speak to their officers about Intellectual and Developmental Disabilities. Courtney Criss, Leadership and Advocacy Manager, and Doug Wennerberg, an Arc trained leader and self advocate, gave three one-hour long presentations to officers about what Intellectual and Developmental Disabilities (IDD) are and provided some scenarios when an officer might encounter someone with IDD. Courtney and Doug also suggested some strategies the officers or first responders could use when approaching a person with IDD and how to interact with them. For example, Doug requested that eye contact not be required and questions should be asked one at a time. Courtney, thinking about her own children with Down syndrome, noted that some people with IDD do not understand what is safe and could bolt into the road; it is important to remove as many agitators as possible to calm the individuals. Acting as a partner with law enforcement, The Arc of Snohomish County hopes to share this information with more police officers and departments.

FEDERAL BILLS OF INTEREST

Right now, Congress is negotiating its "end-of-year package," a bill that includes money to fund the government and that has the power to uplift the health, inclusion, and civil rights of people with disabilities.

All year long, advocates from The Arc have been fighting for critical programs and life-sustaining priorities for people with disabilities. Don't let people with disabilities get left behind!

Decisions are being made NOW, and the last votes of the year will happen in the next few weeks!

Contact your members of Congress and urge them to include the following priorities:

- Increase asset limits for people receiving Supplemental Security Income (SSI) so people can save for emergencies instead of being forced to live in poverty. The asset limit has not been updated since 1989!
- Make the Money Follows the Person (MFP) program permanent to assist people
 with disabilities and seniors to move back home after time in a nursing home or
 congregate setting. This program has already helped over 100,000 people move
 back home, but it needs to be made permanent.
